- Reporting time- 9:00 AM to 10:00 AM. Candidates will be provided a format for application to be fille up on the spot and submit by 10:30AM. No application will be received after 10:30AM.
- 2. If the numbers of eligible candidates are more than 30, a written test will be conducted to shortlist top 10 suitable candidates for the interview.
- Candidates must bring along with them all the original documents in support of age, essential and desirable qualifications, marksheets and degree certificates, with one set of self- attested copies of the same and two recent passport size colour photographs.
- Age Concession: Age relaxation is admissible in respect of SC/ST/OBC candidates, in accordance with the instructions issued by Central Government from time to time.
- 5. No TA/DA will be paid either for attending the interview or joining the post

## Terms and conditions

It is the candidates' responsibility to ascertain and ensure their eligibility as per the
prescribed qualification and experience. Any misinformation detected at any stage will make
the candidate liable for legal action. Permission to appear in the selection process does not
approve the eligibility of the candidate. Even after qualifying the selection process the

- candidate may be rendered disqualified at the time of document verification if he /she does not fulfil the essential eligibility criteria.
- 2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural Project will not vest any right to candidate for appointment within the sanctioned staff strength of CNBC Delhi
- 3. Tenure: The appointment will be purely on contract basis for the period specified above and will not vest any right to claim by the candidate for regular appointment or permanent absorption in CNBC Delhi or ICMR or for continued contractual appointment.
- 4. Expiry of Contract: The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
- 5. Leave: The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy governing extramural / short term research projects as amended from time to time.
- 6. Accommodation: No hostel or any other accommodation will be provided
- 7. Candidates already in government service shall submit "No objection Certificate" from the present employer at the time of interview.
- 8. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 9. Being a multicentre project, the candidate may have to go to other centres like Maulana Azad Medical College, Delhi or All India Institute of Medical Sciences, Delhi once or twice weekly.
- 10. He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- 11. The decision of the competent authority regarding the selection of the candidate will be final and no representation will be entertained in this regard.
- 12. The candidate should not have been convicted by any Court of Law.
- 13. In case any information given or declaration by the candidate is found to be false of if the candidate has wilfully suppressed any material information relevant to his appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.
