3. 5. The list of eligible candidates, schedule of interview and corrigendum, if any, will be published only on the website of the hospital. No separate call letters will be issued for interviews.

8. Candidates presently working on regular/contract/ad-hoc basis or any other basis should enclose 'No Objection Certificate' from their present employer.

10. Candidate should be registered with Medical Council of India /State Medical Council. After selection to the post, the registration with DMC shall be mandatory.
11. Candidates who have applied for the faculty posts as per Candidates should report one hour before the time of interview.

3. The cut off date of age and all other qualifications i.e. experience etc. will be the last date of receipt of application.
